

Proposal / project / idea for improving border control of the State of Israel.

1. Description of the proposal / project / idea

- 1.1 Improving the control of the State border of the State of Israel.
- 1.2 Termination of illegal migration to the State of Israel from economically undeveloped countries with which the State of Israel has a visa-free / visa regime.
- 1.3 Electronic registration of foreign citizens who enter Israel.
- 1.4. Providing full and detailed information to the Embassy / Consulate, the Ministry of Internal Affairs and the Migration Service of Israel about a foreign citizen who plans to enter Israel.
- 1.5 Obtaining an additional electronic permit to enter the State of Israel from the Ministry of Internal Affairs or from the Migration Service of Israel for citizens of visa-free / visa-free countries, citizens of those countries that most often violate the migration legislation, visa regime, stay regime or apply for political asylum without a reason in the State of Israel.
- 1.6 Decrease in the number of foreign persons who will be deported upon entering the State of Israel.
- 1.7 Reduction of political tension with countries, citizens who are most often deported when entering the State of Israel.

2. The essence of the proposal / project / idea

- 2.1 It is necessary to create a web portal where foreign citizens who are going to enter the State of Israel on a visa-free basis will be required to register via e-mail and open a special account on the website-a questionnaire (request for permission to enter Israel), where they will be required to provide the following detailed information about their trip to Israel in order to obtain an additional permit to enter Israel -
 - 2.1.1 - Last name, first name, patronymic and other names, date of birth, place of birth, citizenship, residence permit in other countries, residential addresses, telephone numbers, mobile numbers, e-mail, links to social networks, data on all employees (with the ability to upload a PDF file of the job certificate in Russian or English).
 - 2.1.2 - Data about their parents, grandparents, spouses, former spouses, children, sisters and brothers (last name, first name, patronymic and other names, date of birth, place of birth, citizenship, residential addresses, phone numbers, mobile numbers, e-mail, links to social networks, data about all employees).
 - 2.1.3 - Information about the trip to Israel will also be entered – date of arrival, date of departure, point of arrival and departure, information about places of residence in Israel, for example, hotel details - address, phone, email, website and payment receipt for the hotel or full details of the person or company that accepts the guest.
 - 2.1.4 - It is also necessary to specify the full route about the places visited in Israel with a detailed description – time, date and route, data with whom visits Israel.
 - 2.1.5 - Data on previous trips to Israel – dates of arrival and departure, purpose of arrival, status, and so on.
 - 2.1.6 - Data of the person, about his trip to other countries, as well as data about his visas (with the possibility to upload stamps and visas to the website in PDF file format).
 - 2.1.7. - The person's data on his / her financial condition - a certificate from work, a certificate from the bank on the availability of a certain amount, a bank statement on the movement of funds in the account (with the possibility to upload these certificates and statements to the website in PDF file format).
 - 2.1.8 - Information about his visa, criminal and administrative violations in Israel and other countries (with the ability to upload information about non-criminal records to the website in PDF file format).
 - 2.1.9 - Information about his military duties and services in the army.
 - 2.1.10 - Information about health, medical insurance and vaccinations.
- 2.2 - This request for permission to enter Israel (or an electronic visa application form) will have to be completed by all citizens who have visa-free entry to Israel (for example, citizens of Russia,

Georgia, Ukraine, Moldova, Belarus, Latvia, Brazil, and so on), after filling out the request for permission to enter Israel, it will be considered by the Ministry of Internal Affairs and the Migration Service of Israel, which must give permission to enter Israel in advance before arrival.

2.3 - If the Ministry of Internal Affairs, the Migration Service or the Border Service of Israel gives permission to enter Israel, the person will receive this official permission with a special barcode and codes, which will indicate the data of the person who is allowed to enter Israel. He must have this printed permission when boarding a flight to Israel. The authenticity of the permit can be easily verified on the official website where the permit is issued using the codes on the permit. A foreign national who does not have this official permission to enter Israel will be denied boarding a plane that is flying to Israel.

2.4 - You will not have to pass additional border checks at the border in Israel, an undesirable person (a foreigner) will be denied entry in advance before arriving in Israel, the border service will not have to deport undesirable persons from Israel after arriving in Israel, since an undesirable person (a foreigner) will not be able to come without permission to enter Israel.

2.5 - This will be a more convenient mechanism for controlling visitors to Israel, you can make a list of countries where most visa violators come from and require them to have this official permission to enter Israel.
